#### **ABOUT US**

The Australian Institute of International Affairs (AIIA) is an apolitical, independent membership-based organisation which promotes the objective study of International Affairs. It is apolitical and provides a forum for discussion and debate on international issues. Founded in 1925, it was established as a Federal organisation in 1933. The Institute now has its National Headquarters in Canberra. It has branches in all States and Canberra. Like its sister Institutes in New Zealand, Canada, South Africa and India, it is affiliated with the Royal Institute of International Affairs, Chatham House, London.

The AIIA provides a forum for discussion and research on subjects of topical and continuing interest through meetings, study tours, conferences and seminars addressed by distinguished specialists and public figures.

AllA Victoria is housed in Dyason House in East Melbourne, named after E.C. Dyason, a prominent past member and one of its most generous benefactors.

Membership is open to any individuals who are Australian residents, to corporate bodies, to diplomatic representatives, schools and students.

# PRESIDENT'S REPORT

The past year has been a challenging and frustrating one with so many major events having to be cancelled or postponed. At the same time it has provided a stimulus for us to think strategically about where we as an organisation are going and what must be done to ensure our long-term viability. It is particularly pleasing that we have managed to come through the year with a financial surplus - with government support — and that our membership remains firmly committed. It has been a time of innovation and we have tried our best to continue to provide interesting and important presentations and discussions.



Our web-based and hybrid events (when audiences have been possible!) have been very successful but have also highlighted the

need to upgrade our technological capabilities. We have had one of the most active programs and have introduced a number of new series.

Jim Middleton, former ABC Chief Political Correspondent and Sky News presenter, anchored "Meet the Ambassador", a series of conversations with Canberra-based foreign ambassadors. Rowan Callick has explored with some of the world's leading experts on China that country's complexities, opportunities and threats in a series of three sessions. We have also had a series of four events exploring Australia's geo-political, economic and cultural links with India and Sri Lanka. As one of our speakers said, there's a lot more than Curry, Cricket and Commonwealth!

The restrictions on international travel have meant a suspension of overseas study tours, but we will review this at the end of the calendar year to see whether a study tour may be possible in the first half of 2022. Similarly both the Sir Zelman Cowen Oration and the International Careers Conference have had to be twice postponed now to early next year, despite the considerable work put into them by Council members. The Young Professionals have been active with both networking events when possible and web-based events, and represent a demographic we are keen to engage with more.

Dyason House has been the home of AIIA Victoria since its purchase in September 1963, but over time has become less fit for purpose (e.g. no lift access to the first floor), and maintenance

costs have been increasing. Having considered various alternatives over the past three years, the Council at an Extraordinary Council meeting on 22 March 2021 decided unanimously on the sale of the property. We intend that new premises will both meet our ongoing business needs but that there will be a net financial yield which will place AIIA Victoria on a firmer financial foundation into the future. A contract was exchanged on 6 August 2021 with a settlement date of August 2022 and leaseback terms thereafter to give us time to purchase, fit out and move into our new home. The search for New Dyason House is on!

My thanks to our Council members who have worked hard throughout the year to maintain an interesting program despite the challenges, and to Robyn Byrne OAM who having served on the Council for six years is not eligible for re-election in accordance with clause 14.9 (a) of the AIIA VIC Constitution.

My particular thanks to the Executive Director, Alastair Roff, and to the team of interns and volunteers who are so vital to our ongoing operations. I am very grateful to Council Member James Carey and Admin Assistant Jessica Wayne, who stepped in at short notice to cover for Alastair Roff while he was in hospital.

Thank you all for your continuing and generous support for our Institute. Please stay well, keep fit and remain interested in International Affairs! We look forward to better times ahead.

#### **FINANCES**

We are pleased to report that AIIA Victoria last year returned a surplus of \$31,548.

By comparison, the surplus in the previous financial year was \$10,317 and despite the COVID-19 pandemic and the impact on our operating activities which is a great outcome.

Both Federal and State government support packages greatly assisted in maintaining the financial performance of the Institute including \$76,372 of income from the various support packages. Our members and friends of the Institute again gave generously, and we recognised \$35,036 of donations during the year.

Cash reserves at the end of the financial year have been maintained from last year with over \$240,000 in cash. In addition, the sale of Dyason House provides further certainty for the Institute's financial position Further to this, there is recognition of \$2,316,847 in the income statement which is reflective of the increase in carrying value of Dyason House in the financial statements less costs of sale.

Obviously, the ongoing pandemic creates significant financial uncertainty, however the Executive and the Council members will continue to undertake strict monitoring of the financial performance against the budget. Given the strong financial position at balance date, we are buoyed for the future of the Institute.

## **EXECUTIVE DIRECTOR'S REPORT**

I am pleased to report on a very active year for of the Institute despite the ongoing challenges of lockdowns. Thanks are due to members of Council for their support and involvement throughout the year, and to Asha Reeves and Jessica Wayne for so competently helping to run the Executive Office.

Equally, we could not operate without the time and effort so generously given by our many Interns and volunteers, and more details of their contribution are given below. One way that we can give back to them is to provide references to potential employers. It is clear that the AIIA is regarded as an important reference by the number of times we are contacted, particularly by government



agencies, and it is encouraging to see the number of former AIIA interns and volunteers who continue to succeed in obtaining employment even in the current times.

46 regular events were held this year covering a wide range of international topics, in which over 4,000 members and guests participated. It is galling to be reporting for a second consecutive year on the impact of COVID-19, but it is highlighted by the fact that well over half of our events have been held purely online. We covered a wide range of topics and speakers (listed in the appendix on pages 10-11). A booklet highlighting the 2020-21 Year in Review is available here. We are always interested in suggestions from members on topics to cover or on speakers whom we should consider inviting.

The <u>Walter Mangold Trust Fund</u> has again in calendar years 2020 and 2021 provided generous support to our young people. Their funding has allowed over 750 student attendances at Dyason House events free of charge and enabled us to keep student membership rates at an affordable level.

Our aim is to ensure the sustainability of the Institute post-COVID in what is an increasingly competitive environment and we are confident that we have the team to meet this challenge.

Finally, my thanks for the interest and support shown by all members and their guests at our events, and we look forward to when we can once again regularly meet up in person.
